

**THE FIFE COUNCIL (VARIOUS STREETS, STEELEND –
30 M.P.H. SPEED LIMIT) ORDER 2024**

Fife Council propose to make an Order under the Road Traffic Regulation Act 1984 to introduce a 30 m.p.h. speed limit on the following lengths of road at Steelend:- B913 Main St/B914 Main Rd from 1 Upper Kinneddar to 40m east of Midfield Terr approx 1370m. B913 Saline to Gowkhill from B914 southerly for 20m. The entire length of Ravenscraig Terr, Knockhill Terr and Main St (cul-de-sac).

**THE FIFE COUNCIL (VARIOUS STREETS, STEELEND –
30 M.P.H. SPEED LIMIT) ORDER 2024**

The Fife Council (“the Council”) in exercise of the powers conferred on them under sections 84(1) and 124(1) of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police for the Council’s area in accordance with Part III of Schedule 9 to the said Act hereby make the following Order:-

1. This Order may be cited as "The Fife Council (Various Streets, Steelend - 30 m.p.h. Speed Limit) Order 2024” and shall come into operation on the day of Two Thousand and Twenty Four.
2. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in the Schedule to this Order.
3. Nothing in this Order shall apply to any vehicle which falls within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
4. The Fife Council Regional Council (B914 Main Road, Steelend) (40 m.p.h. Speed Limit) Order 1995 and The Fife Council (B914 Saline to Steelend – 40 m.p.h. Speed Limit) Order 2011 will be revoked in their entirety.
5. Drawing Number TRO24_41 delineated in black is annexed and signed as relative hereto.
