## **Regard given to the Local Development Plan**

In general terms, the view of those consulted and the vision set out within the St Andrews LPP is well aligned to the vision and strategy of the 2017 FIFEPIan, and we anticipate similar alignment to the next LDP. However, it must be stated that there is often a disappointing gap between intent and implementation, with changes or weakening of community benefits emerging after consent has been awarded, or weak enforcement in place. One particular example of this 'implementation gap' is the lack of affordable housing being built in the town despite a policy that recommends it.

Below are some key changes that the LPP advocates in the next iteration of the LDP. These have all been strongly vocalised in our stakeholder consultation.

**Housing availability (Policy 2)** – Because the issue of housing availability came through so strongly in the community consultation, and the current housing market assessment only stretches to 2026, the LPP advocates the commissioning of a more up to date Housing Need and Demand Analysis for the St Andrews town only (not St Andrews and North East Fife as in the current FIFEPlan). The St Andrews LPP also advocates the use of planning obligations and other constraints limiting use for non-permanent occupancy. Restrictions on short term lets or holiday accommodation is an omission in FIFEPlan's Policy 4. As per the Evidence Report, of the 12,287 tenures in St Andrews, 4.83% are short-term lets, 1.74% second homes, 8.49% HMOs – almost as much as the 8.77% Fife Council stock. Housing availability came through very strongly in the LPP consultation, as the community suffers from the loss of permanent housing in favour of short-term lets or holiday accommodation. The impact of this on the housing market in the town excludes local people and has a negative impact on the life of the town.

Affordable housing (Policy 2) – The St Andrews LPP advocates affordable housing contributions to as a pre-condition for every development for open market housing. The threshold of 30% of new build homes to be allocated as affordable should also be increased and enforced more rigorously. Housing affordability was a dominant issue in the community consultation, and residents and students feel that housing is not affordable. Without pre-conditions, affordable housing will not get built in St Andrews and local people who work here will not be able to afford to live here – with the consequential traffic/commuter problems that were strongly identified within the consultation.

**Built and Historic Environment (Policy 14)** – The St Andrews LPP advocates incorporating a specific reference to the St Andrews Design Guidelines into the FIFEPlan. This document supplements the Conservation Area Guidance and the two must work in tandem with one another. This came through strongly in the community consultation, that St Andrews town centre was run down and not being looked after, or its unique historical character maintained.

#### **Settlement Proposals/Priority Projects**

Most of the projects within the 2017 FIFEPlan's St Andrews Settlement Plan have already had planning permission granted and are well underway if not complete. We assume the next iteration will contain new proposals.

The St Andrews LPP contains 52 projects, listed below. Not all proposals have a mark on the map. Developable space within St Andrews is limited and the LPP represents a desire for projects to progress in the town, but the optimum location(s) may still subject to further analysis. We also recognise some proposals in the LPP are not planning matters for the Local Development Plan, but they represent a direction of travel desired by the community. We look forward to working with Fife Council and others to help to make them a reality.
