Local Authorities are required to carry our regular reviews of their polling districts and polling places, in accordance with Section 18(c) of the Representation of the People Act 1983. The 2024 review of polling districts and polling places commenced on Monday 16 December 2024. It is our practice to continuously review our polling arrangements and where necessary make amendments to ensure that all electors, including those who are disabled, have access to such reasonable facilities for voting as are practicable. Significant preparatory work has been undertaken in preparing the consultation proposals.

Consultation is an important part of the review process and in this respect, I have enclosed a copy of the consultation document which details the current polling arrangements, draft proposals and my comments as Returning Officer on these proposals.
