Community Trust with Balcarres Estate

On the 21st of April the The Colinsburgh Community Trust held an event with Anthony Crawford, owner of the Balcarres Estate. At the meeting he expressed a wish to tie the development of the Estate with the needs and wishes of the village.

The Local Place Plan

Residents of the village were surveyed by the Colinsburgh and Kilconquhar Community Council so that they can submit a Local Place Plan to Fife Council. As your feedback applies to both, the Community Trust and Community Council are now sharing information and working together for the Local Place Plan.

Why we're working together

It's important that we inform Fife Council of our ideas so we can develop them more effectively. The Local Place plan is a key document to inform Fife Council of what a community needs and wants. The projects that come from our work with The Balcarres Estate will be pursued and developed independently of the Place Plan. The inclusion of the ideas from the event on the 21st of April into the Place Plan is to alert Fife Council to developments that might need their cooperation.

Ideas consultation period

The Colinsburgh Community Trust is starting to work with Anthony Crawford to evaluate and prioritise these ideas. There are projects we can start soon, and some we will have to schedule for later. We will circulate a full evaluation in August.

Important Dates

20th of May is the final date for Community Trust working with Balcarres Estate submissions.
The proposed Local Place Plan will have a public consultation from **2nd June to 28th June**.
The Local Place Plan will be submitted to Fife Council on **30th June**.
The Colinsburgh Community Trust working with Balcarres Estate will publish and circulate their Development Plan in **August**.



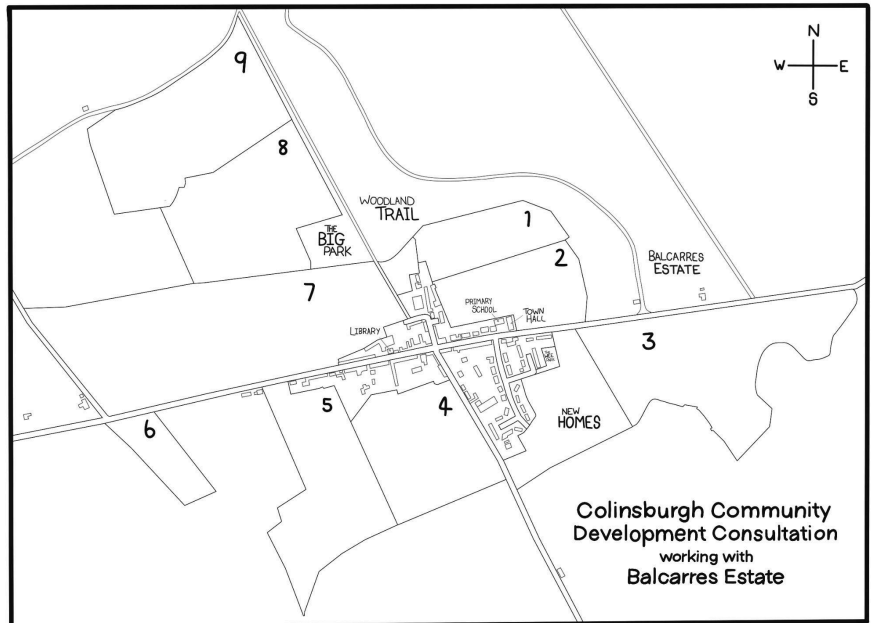

Colinsburgh Community Garden

Community Orchard

"Tie in orchard(s) with a micro-brewery using an outbuilding "Balcarres Estate Cider" or "Colinsburgh Cider" Tastings/small bar area (similar to Bow House)" (305)

"Allotments/Orchard" (145)

"The south east strip of land between the Hall and the woodland walk - have approx. half the length as parking spaces leading to a community orchard at the woodland end of the strip. Establish a strip of wildflowers between the parking area and the rest of the field to separate parked cars from farmed land and have a footpath between the 2 to provide safer access to the woodland walk." (316)

Love the idea of a community orchard and even better if it can be tied into something that could raise funds for the community or supply fruit to a small business paying rent to the estate.

This would be great as part of the Eco village or forest garden ideas.

Great idea, we often have a surplus of fruit in the village

Wild Garden

"a wild garden and attached small wood next to car park, town hall. Grow trees, up biodiversity, up wildlife habitat and mitigate against industrial farming" (161)

A great way to link into the existing woodland walks and extend wildlife corridors.

this would be great to support an orchard if the two were nearby

Colinsburgh Kids' Community Garden

"a place for kids to grow their own fruit and flowers, and to learn skills from adults in the village. Great work experience." (144)

"Children's Garden" (146)

Definitely a great idea - Ideally could be near a building where an educational facility could be created. Combine with the polytunnel idea? Preferably have an electrical supply (sustainable - wind/solar?) and a water supply (harvested rainwater?)

It is so important for children to understand where their food comes from and it's link to wildlife/pollinators/the environment. A great way to encourage interaction between generations.

Native Planting

"Planting many many native trees far and wide. Ideally around the borders of all numbered sections." (112)

"easier and safer walk to wood walk in field?" (support for 112)

Definitely - This would increase shelter for wildlife and pollinators and benefit agricultural production as well as the environment and enhance many of the other ideas proposed

This would be great as part of the Eco village or forest garden ideas.

Community Polytunnel Allotments

"community allotments plots under polytunnel. This would allow us to grow a wider range of home produce for community use, at the free provision events and for home use. Plots could be shared and tended by all volunteers." (163)

Yes please

A great way for the community to get growing with support from those with more experience.

Community Berry Farm

"a polytunnel to grow fruit to sell as fundraising for community trust" (172)

Great idea. Not limited to growing fruit - could grow all sorts of veg especially salads. Ideally would include a water harvesting system to collect rainwater.

Expanded Woodland Walk

Woodland Walk

"Improve and extend woodland walk - better, more footpaths, seating, picnic area(s) (accessibility essential)" (113)

"allow plenty of long grass round fields for butterflies and moths" (support for 113)

"Community Woodland: Include walks, so that those of us who can't walk too far can do varying lengths. Native trees and plants. In conjunction with woodland trust." (114)

"Lovely idea for folks who can't walk too far." (support for 114)

"More walking paths round the village" (118)

"Info Boards for Walks: Near town hall have a display with maps and pictures, describe how to get to nice areas on foot." (126)

"Extension or expansion with more paths, better accessibility" (129)

"Safe Walking Areas for elderly. Field margin a reasonable width. Suggestion South Wynd large field which incorporates what was at one time Butchers Field. Could be a reasonable distance and circular" (132)

"lengthen woodland walk. Plant trees along edges shown on map, create, build pathway, bridge over the burn, exit at north wynd next to park road, potentially keeping dogs separate from cyclists, cars, groups of children. Start walk behind or in front of car park adjacent to town hall." (162)

"Woodland walks with an outdoor exercise, keep fit stops on the circuit. Could this be extended into the big play park and then on to join the new ... path west over the Balcarres Estate." (168)

"The south east strip of land between the Hall and the woodland walk - have approx. half the length as parking spaces leading to a community orchard at the woodland end of the strip. Establish a strip of wildflowers between the parking area and the rest of the field to separate parked cars from farmed land and have a footpath between the 2 to provide safer access to the woodland walk." (316)

Longer woodland walk with a wildflower meadow would be fabulous!!!

It would be great to make more of the woodland and local outside environment more accessible to those with limited mobility

This would be great as part of the Eco village or forest garden ideas.

Animal Trail

"a place to learn about local animals with signs and cameras to watch from home" (159)

Great idea and not difficult to do. Could definitely get help from lots of organisations e.g. RSPB, Wildlife Trust, Bat Conservation Trust. etc

This would be an excellent addition to an eco-site, orchard, playground and cafe/bar. A small centre learning centre as part of a community building would be a good addition.

Adventure Trail

"Adventure trail with natural built shelters. This project would take reclaimed, upcycled objects and materials and transform them into an activity for the young people of the village to explore, play on and play with. There is also an opportunity to build natural material structures as a learning activity and then outdoor place, space to play, spend time that is sheltered. I can help with design and building." (143)

Great idea and could combine with the idea of a 'Man Shed' to make some structures

This would be great as part of the Eco village or forest garden ideas.

Forest Garden

"Forest Garden outdoor learning centre with a sustainable design focus.

A forest garden of edible and companion plants grown and designed around Permaculture and regenerative growing principles. A complete system to serve as a learning, well-being, meeting, creative, and outdoor activity space. Central to the idea is land to plant a forest garden, an indoor/sheltered space from the elements for lessons and workshops, and a storage shed for tools and equipment.

This space is an opportunity for young and old to play with and learn how to regenerate and care for our environment, food source (soil), and commune with each other in a natural environment. There could be outdoor concerts, creative workshops, nature, activities, animal behaviour lessons, and so on. The buildings would/could be made of natural materials already on-site and nearby like cob and straw bale.

It's ambitious *and* doable in stages with most of the materials already on site. This idea brings together many of the other ideas for children, environment, and recreation into one combined space and purpose.

I can help with research, design, and planning of the garden and buildings. I can also offer workshops/activities. The first stage would be to plan the area taking into consideration how to combine the ideas into one space." (310)

Absolutely agree with the idea and Kim's comments

potential tie in with community garden and community polytunnel for grow your own, orchards and outdoor education

Town Hall Outdoors Event Space

"having a big lawn next to the town hall for events - bouncy castles, marquees, sports day, cricket, plant sales, car boot sales." (130)

"rent time to food trucks in an area along the main road just outside village to entice those driving through. Use funds raised from rent to maintain bins, picnic benches, profits for community trust." (115)

"Summer activities for kids water fights or slip in slide and stuff to keep children entertained during the summer holidays and for parents to get together and chat. I think it would be a good idea so children and parents to get together during the summer holidays." (302)

"It's not a new idea, but I fully support sections 1 and 2 on the map being used for parking for the school, hall and village generally. "Accessible outdoor community space, a place for local art, sensory garden, solar lighting ,history boards about the area.?Behind school, flowerbeds, seating, place for Xmas tree and community gatherings, Armistice Day, carol singing , New year celebration with a community clock supported by Friends of the Garden to maintain the area. Happy to assist with gardening to maintain the space." (306)

"I think there should be a car park alongside village hall leading ... to a PARK/PITCH behind the school. The present park should go back to the estate." (135)

It would be great to have an outdoor space for events closer to the Town Hall so there is a backup indoor space in the event of poor weather (do we have such a thing in Scotland??!!)

We need the pavilion done up in the summer new people would come up too new goals etc

Car park beside the hall is a great idea and much needed. A separate events space is also great idea and would bring people together at New Year etc

Summer Fayre

"get the whole community involved to establish the Summer Fayre as an annual tradition - fun day out for all and a great fundraising opportunity for Parent Council and community projects" (101)

"Annual Summer Fayre a great idea." (102)

This would be a great opportunity to bring people together and have fun. The annual cricket matches on the big park used to be a great success. Would really help to build the community.

Great idea. Anything which gets the whole community together is great.

Fantastic idea! Something seasonal for the village to look forward to every year.

Town Hall Storage

"The town hall needs more storage for furniture and equipment if some land was made available to the east side or behind the hall so that a container or building could be erected with easy access to the east side door" (170)

Essential in order to maximise use (and therefore income) of the Town Hall rooms

Car Parking

"Limit parking on main street - ideally to one side of the street (limited parking bays) Create a small walled parking area behind school for drop off and also for extra parking (spaces taken away from main street with electric) Similar to model in Kirkcaldy across from volunteer garden (stone walled with herbaceous borders - aesthetically pleasing and friendly to the environment.) Do not add speed bumps - largo is petitioning to get rid of them." (111)

"Parking at the side of the Town Hall, enough (40/50) so that people have easy parking for any event at the hall rather than fight for spaces on the Main Street. This would help alleviate at fundraising and other village events" (171)

"a car park in the field of the side of the Town Hall. Also if land allows an area where you can sit and enjoy the surroundings." (151)

"functions in the hall would be better attended and fundraising would be increased if people travelling to the town hall could be assured of a parking place near to the hall" (support for 151)

"car park and walking path east of the hall. Path would lead to woodland trail, nicer than walking next to cars going 60 mph" (152)

"car park adjacent to Town Hall" (153)

"parking for residents in field 7 to ease congestion on Main Street" (149)

"Motorhome parking: charge to apply, adjacent to town hall some spaces for motorhomes, toilets for public, visitor use, some electric charging points, a drain point, water fill up" (150)

"[car park] construction to the East side of Colinsburgh Town Hall if Balcarres Estate would agree to that" (136)

"any parking facilities would be great" (142)

"maybe a car parking area at the east of the hall with a 10mtr strip of land from the hall running along the road side to the woods planted up with native trees, linking up with the fairy woodland walk trees. This would allow dog walkers safety walking through a wooded area rather than along the main street." (202)

"Using the field for a car park" (309)

"Car parking at East side of Town Hall. Would take cars off the street especially when functions on in hall. Traffic lights at both ends of the village which would only turn green if correct speed being done." (138)

"The most urgent issue of our time is the climate emergency. Anything we can do to support carbon sequestration, land cooling and water storage to reduce flooding, will support a resilient community. There are lots of ways to do this, but I'm not an environmentalist and my request is that we support the

ideas of the community by inviting in some expertise. Some suggestions could be; planting an orchard, tree planting, planting a nuttery for diverse harvesting options.

"I, like most if not all, Colinsburgh residents, am concerned about the traffic - the speed and number of vehicles - as well as the sheer number (and size) of cars. We live on the Main Street and we cannot afford the costs of maintaining our home here if something isn't done to change the amount of traffic. I agree, parking is a nightmare, but I implore the community not to build a concrete or asphalt carpark. There are options for 'green' car parks, but adding more concrete and asphalt to a green and beautiful area, will have a negative effect on the climate as well as how we value our neighbourhood.

My idea is a request that whatever we do we think about the environmental impact. Whatever the plan, be it a car park, playground, or community garden, that we do it with the climate crisis in mind. Using natural materials, ensuring there is room for carbon sequestering/water storing plants and trees." (311)

Just wondering if we might offer the facility at a reduced rate to residents, a bit like golf clubs having a reduced rate for locals. What do we mean by facility ?Dogs off lead with a dog gymkhana experience ?Kilkenny dog run charge £11 for 1-2 dogs for 1 hour. Perhaps we can charge a bit more for those visiting the area on holiday . We need to cover the outlay, fencing etc, insurance but maybe nice for locals to have it seriously subsidised. Could have a tag to show you are allowed to use 😊

I had thought about local pricing too - someone suggested a fair monthly fee for residents that would give them credits to book slots rather than a one off charge.

This is a great idea! I would love a safe and secure place to let my dog run freely, to train them and get use to the noise of traffic too is always handy!

Brilliant idea. I would definitely use it.

I would use this for my dog, and the dog I look after. They're both drawn like magnets to the burn and I don't always have time to bath them after a walk, so a way to keep them safe from water and traffic would be excellent! Bonus points if it has some extras like dog agility ramps etc

We are very fortunate with excellent dog walks in this area. Not sure there will be enough demand for an area we have to pay to walk our dogs?

Retain Farming

"We believe that this land should be valued for what it is, prime agricultural land, and recognised, therefore, as a precious resource, which we destroy at our peril! This could be the opportunity to farm in a more environmentally friendly way, by adding, for instance, large margins of nectar-rich planting, to attract and maintain wildlife populations. More hedges could be planted, and the land could be farmed organically. Looking to the future, we should be mindful of not destroying land which could be used to feed the population, reducing food miles etc. A village orchard could be combined with the growing of crops, as it has been on the outskirts of Newburgh. Our greatest hope is that the release of this land allows its agricultural potential to be developed in a more sustainable way, and that it is not lost forever under cement. Devastated to see suggestion for Solar farm in fields 4 and 5 south of Main Street. Infrastructure alone will destroy some of the best agricultural land in the area for ever. Why industrialise a rural area? Not development but destruction! Why not put solar panels on the roof of every house in new housing development instead?"(203)

Farming sustainably, with regenerative agriculture could be retained as part of the Eco village or forest garden ideas.

Environmental Impact

"The most urgent issue of our time is the climate emergency. Anything we can do to support carbon sequestration, land cooling and water storage to reduce flooding, will support a resilient community. There are lots of ways to do this, but I'm not an environmentalist and my request is that we support the ideas of the community by inviting in some expertise. Some suggestions could be; planting an orchard, tree planting, planting a nuttery for diverse harvesting options.

I, like most if not all, Colinsburgh residents, am concerned about the traffic - the speed and number of vehicles - as well as the sheer number (and size) of cars. We live on the Main Street and we cannot afford the costs of maintaining our home here if something isn't done to change the amount of traffic. I agree, parking is a nightmare, but I implore the community not to build a concrete or asphalt carpark. There are options for 'green' car parks, but adding more concrete and asphalt to a green and beautiful area, will have a negative effect on the climate as well as how we value our neighbourhood.

My idea is a request that whatever we do we think about the environmental impact. Whatever the plan, be it a car park, playground, or community garden, that we do it with the climate crisis in mind. Using natural materials, ensuring there is room for carbon sequestering/water storing plants and trees." (311)

Eco Village

"An eco village. This would take some planning and good deal of time to think it through, recruit people, and build. The obstacles are not insurmountable as there are examples elsewhere in the UK, one well developed example in the north of Scotland. The idea is to use the materials in the area as well as reclaimed and found and borrowed and secondhand to build an intentional community that is self sustaining, using natural energy sources such as geothermal and solar, growing their own food, and

offering workshops, retreats, and community businesses based on whatever specialties the people who live in the community have. I suspect they actively recruited for members wanting to live in a sustainable community." (312)

Sports Proposals

Basketball Court

"The Big Park used to have a putting green and a basketball court in addition to the existing football pitches, and it's a real shame this provision has gone! Variety away from football is good for the kids!" (120)

Anything to encourage and facilitate exercise, especially outdoors is a good idea

Yes!

the children of Colinsburgh Primary have already done so well in all sports this academic year (top of the league!) even without facilities, so I'm certain we'd be raising future sports legends if they had options for sport in the village

Pump Track

"Bike, rollerskate, scooter track: A pump track is a series of hills, slopes and bends on an asphalt track, that can be used by all kinds of wheeled sports equipment. It's an excellent way to promote exercise and time spent outdoors, can be used for community events, and gives kids a safe place to cycle. Kids here love their bikes and scooters but our roads aren't safe for them!

An excellent example of this idea has been very successful can be found at Kennoway pump track, near Sandy Brae Community Centre. Not only are the local children always playing there, it attracts children from neighbouring villages who are jealous of facilities! They regularly host biking events, helping to further promote cycling in Scotland. They host bike swaps, where people trade outgrown bikes among families, ensuring no children are 'priced out' of cycling. I'm in contact with the driving force behind getting Kennoway's track off the ground, and he reported lots of 'invisible benefits' to the track too - such as volunteers getting through certifications. Ride leader training, child protection training food hygiene

certificates for hosting community BBQs, first aid training etc, and bike maintenance training. Our community already showed interest in a skatepark many years ago, a pump track builds on this idea but with greater inclusivity. Anything that can improve the offering of outdoor activities in our community for generations to come would be an excellent investment!" (127)

"a place where people young and older, to go and enjoy themselves." (137)

Skate Park

"I had two suggestions. An outdoor public skatepark aimed at a beginner/intermediate skill set. This would provide a much needed facility in the east neuk and also a great addition to a small community like colinsburgh.

My second thought was that of an indoor facility potentially making use of old barns/farm space. Indoor facilities thrive through the wetter and colder months when outdoor skateparks are unusable. This would demand an entry fee to cover maintenance and the running of the facility but there is potential for a great multi use space. I'm not entirely sure what building would be potential for such an idea but I do think it would also be a great community enterprise.

I have 7 years experience specifically building concrete skateparks although I know public parks need to go through the tender process. I think it's such a great opportunity for the community to have their say and an equally great gesture from Balcarres. I'm sure whatever plans go ahead will be benefit to the community and hopefully these ideas don't seem too far out the box.

If the indoor skatepark was popular I'd be quite happy to take that project on. funding would have to be secured either way although I do also know some people that do exactly that for projects like this." (301)

Renewable Energy Proposals

Town Hall Heat Pump

"Combined use of air source heat pump for school and town hall. Fife council should help with funding. And could be used for boosting hall heating out of school hours." (155)

I have been informed by others that the heat pumps create noise? It is so difficult to hear speakers in the hall as it is. I speak , not just for myself with my hearing problem, but others with perfect hearing. On the terrific community engagement day, lots of people could not hear the speakers and I know of 3 who left because of that. Speakers used to use microphone in the hall but not now. Prepared to be corrected on the noise of the heat pumps.

Yea! And for the library.

Ground Source Heat Pump

 GB INNOVATION PRESENTATIONth.ppsx

"Hello, we are the Golden Builders from the village of Colinsburgh, and we gather after school in our community library for Lego Club. Here are our thoughts and feelings on our energy journey solution: It's crucial to address the energy crisis and move away from fossil fuels. We aim for a sustainable solution. In our village with many old stone buildings, heating is costly due to inefficiency and heat loss. To combat this, we considered using geothermal energy. Geothermal energy, derived from the Earth's core, could be the answer to our heating needs. Exploring geothermal energy options, we found various methods, including ground source heat pumps. While traditional geothermal plants may not suit our village, a community ground source heat pump could be a collective solution. This large-scale pump would involve deep boreholes and a network of pipes to distribute heat efficiently. Consulting with villagers, we received valuable input on the practical aspects and feasibility of the project. Learning from other communities, we discovered the depth and length requirements for effective geothermal heating systems. Professionals advised us on the best practices, emphasising the importance of underfloor heating for optimal results. Understanding the need for occasional high-temperature water circulation, we explored additional electricity sources to support the system."

Solar Farm

"solar farm poss on areas 4 and 5 as south facing, sloping land so panels could be stepped. Good size of land for arrays. Ease to remove so land not damaged and indeed grazing sheep can use if grassed also. Profits could be reused into other community projects." (158)

Rest of gold 2 as woodland addition to existing woods. Parking on field 7 behind even number on main street, possible access from new round about at West of village. Would slow traffic at both ends of village and reduce risks crossing fast traffic to access new housing." (314)

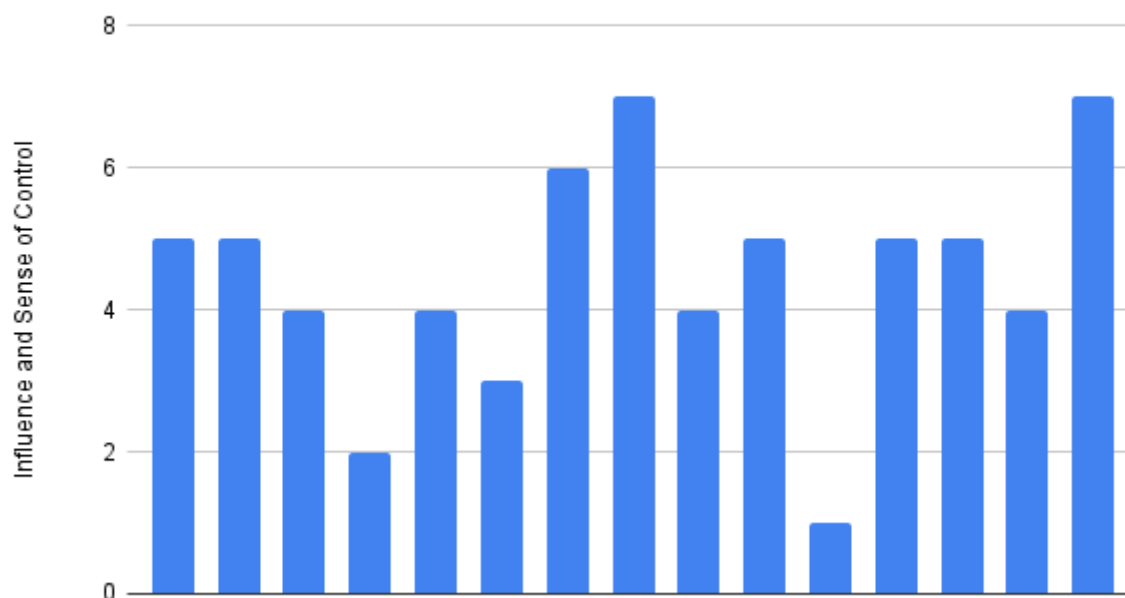
