The Fife Council ("the Council") in exercise of the powers conferred on them under sections 84(1) and 124(1) of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police for the Council's area in accordance with Part III of Schedule 9 to the said Act hereby make the following Order:-

1. This Order may be cited as "The Fife Council (Toll Road, Guardbridge and Station Road, Leuchars - 30 M.P.H. Speed Limit) Order 2025" and shall come into operation on the _____ day of _____ Two Thousand and Twenty Five.
2. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in the Schedule to this Order.
3. Nothing in this Order shall apply to any vehicle which falls within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
4. Drawing number TRO24_59 showing the roads affected by this Order delineated in black is annexed and signed as relative hereto.

30 m.p.h. Speed Limit

Toll Road, Guardbridge	From a point 12 metres or thereby west of the junction with Station Road to a point 81 metres or thereby in a southeasterly direction from the junction with Station Road
Station Road, Leuchars	From the junction with Toll Road in a northerly direction for 25 metres or thereby
