Response to the Petition regarding the football pitch and car parking at Auchmuty High School.

Introduction

Since the opening of the artificial grass pitch at Auchmuty High School in October 2014, residents have made regular complaints about members of the public parking in Auchmuty Road adjacent to the football pitch. There have also been occasional complaints made by residents regarding balls being kicked over the fence and hitting cars or property.

Parking

With regards to parking, a small minority of players, coaches and spectators do park on Auchmuty Road. This is the nearest point of access to the pitch. A report was taken to area committee in June 2015 regarding this issue. The summary findings were:

- Fife council employees cannot prevent members of the public parking on a public road.
- Creating a resident only parking area would prevent visitors to residents' houses being able to park in the street

As a compromise solution, it was agreed that a sign would be installed at the Auchmuty Road entrance, advising pitch users to park in the designated school car park. Users with pitch bookings were also written to advising that they direct all their participants and spectators to park in the school car park. Fife Council staff also made regular visits to the area to request that customers do not park in the street adjacent to the pitch. This process is repeated every year but tends to have a limited effect.

Balls being kicked over the fence and hitting property

Footballs can occasionally be kicked over the fence at the street end of the pitch. This can happen during formal school or community use of the pitch or during unauthorised use. One of the suggestions on the petition is to remove the goals at the street end. Removing the goals is not a viable option due to lack of suitable storage and the time and number of staff required to dismantle and re-assemble the goals before and after a booking.

Increasing the height of the fence behind the goals at the Auchmuty Road end would reduce the likelihood of balls going over the fence. This action might however be counterproductive, as it could increase the number of users who use this end of the pitch. It is also likely that costs of a new higher fence would be significant.

Unauthorised Access

There are occasions when there has been unauthorised use of the pitch by local young people. Unauthorised use is a seasonal issue that happens mainly during the summer period or during other school holiday periods. It tends to be young people from the local area who either climb over the fence or cut a hole in the fence to gain access. In most cases the young people do not act unreasonably when they are on the pitch. There has however been reports of some anti-social behaviour, including dropping litter and inappropriate language. One anecdotal example is a report from school janitorial staff that a group of young people returned to cut a new hole in the fence, five minutes after workmen had left from repairing a previous hole.

The peak demand period for access to the pitch by local clubs and groups is October – April each year. During this period, unauthorised access is very limited. There are approximately 30 bookings per week between 6.00 – 9.00pm every evening and occasional weekend bookings for matches. This limits the opportunity for young people to gain unauthorised access.

Peter Grant MP case ref. PG3832, June 2020, also received a complaint from a local resident regarding young people accessing the pitch during the Covid lockdown period. As a result of a request from Mr Grant's office to advise what action Fife Council was taking with regards to this matter, the following action was agreed.

- Detached youth workers attended the pitch and contacted local young people who were accessing the pitch. Agreement was reached with the youth workers and young people that they could access the pitch with agreed conditions including a curfew of 10.00pm
- Council Officers from the safer communities team also added the pitch at Auchmuty to their daily routine check list.

Further Recommendations

The issues experienced by residents in Auchmuty Road have no short term, easy fix. There are seasonal re-occurring challenges that require a cross service approach to achieve a long-term sustainable solution. Communities & Neighbourhoods, Education and Police representatives could attend ward meetings to agree seasonal approaches to dealing with these issues.

Street Naming Consultation

Wards Affected: (Ward 14) Glenrothes North, Leslie and Markinch

Purpose

Under Section 97 of the Civic Government (Scotland) Act 1982 this report proposes that the name 'Annie Swan Drive' be approved as a new street name at the development on Land Adjacent to Dairy, Main Street, Star. A copy of the site plan for the development is appended showing the layout of the new streets.

Recommendation(s)

The new street name 'Annie Swan Drive' to be adopted for the Campion Homes development on Land Adjacent to Dairy, Main Street, Star.

Resource Implications

There are no resource implications associated with this report.

Legal & Risk Implications

There are no Legal or Risk implications associated with this report.

Impact Assessment

There is no Policy and Impact Assessment required for this report as the report does not propose a change or revision to existing policies and practices.

Consultation

The property developer, Campion Homes, was consulted on 15th April, 2020 and provided suggestions to be considered by the elected ward members.

The local community council was contacted on 16th June, 2020 but no suggestions were received.

The elected ward members (Councillors Fiona Grant, Jan Wincott, John Beare and Mick Green) were consulted on 27th June, 2020 concerning the need for two new street names for this development. During the consultation street name suggestions were proposed by Cllr John Beare.

The preferred names 'Cuinin Road' and 'Annie Swan Drive' are supported by all elected ward members with no objections received.

The proposed name 'Cuinin Road' complies with Street Naming and Numbering – Policy and Procedures, has been approved by the elected ward members and is therefore suitable for adoption. This street name has been approved by powers delegated to the Business & Employability service.

The proposed name 'Annie Swan Drive' conflicts with Street Naming and Numbering Policies and Procedures para 2.12 – "Street names very similar to existing streets in Fife" with a number of existing streets named "Swan" and will therefore be referred to the Glenrothes Area Committee for decision.

In advance of this consultation being brought to the Glenrothes Area Committee, Councillor John Beare has contacted existing family members of Annie S. Swan who consent to the proposed street name 'Annie Swan Drive'.

1.0 Background

- 1.1 Two new street names are required for the roads serving the Campion Homes development on Land Adjacent to Dairy, Main Street, Star.
- 1.2 Cuinin Road recognises Cuinin Hill which is within direct line of sight of the development this meets the requirements of policy, does not conflict with any existing street name in Fife and has received no objection from elected ward members.
- 1.3 The proposed name 'Cuinin Road' complies with Street Naming and Numbering Policy and Procedures, has been approved by the elected ward members and is therefore suitable for adoption. This street name has been approved by powers delegated to the Business & Employability service.
- 1.4 Annie Swan Drive honours the writer Annie S. Swan who lived in Star (although born in Midlothian) and it is understood that she wrote 'At the Gates of Eden' in 1887 while resident there. The suggestion has not received any objection from elected ward members.
- 1.5 The suggestion "Annie Swan Drive" conflicts with SN&NPP para 2.12 "Street names very similar to existing streets in Fife" with a number of existing streets named "Swan" and is therefore being referred to the Area Committee for decision.

2.0 Conclusions

2.1 The proposed street names for this development recognise Cuinin Hill, a natural feature of the area, and Annie S. Swan, a noteworthy person of the local area. The names have been approved by local ward members. It is for the Glenrothes Area Committee to decide on final approval of 'Annie Swan Drive' as an exception to the criteria stated in SN&NPP para 2.12.



Local Community Planning Budget Request -Wards 14 and 15, Glenrothes: CCTV

Report by: Paul Vaughan, Head of Communities and Neighbourhoods Service

Wards Affected: Wards 14 and 15

Purpose

This report seeks approval from Members to purchase CCTV cameras – one each for Wards 14 and 15. The cameras will be used across each of the Wards to help tackle anti-social behaviour.

Recommendation(s)

Members are asked to approve the purchase of two CCTV cameras – one each for Wards 14 and 15.

Resource Implications

There is adequate funding from Local Community Planning budgets to cover the costs of the cameras for Wards 14 and 15.

Legal & Risk Implications

There are no Legal and Risk Implications associated with the proposals included in this report.

Impact Assessment

An EqIA is not required because the report does not propose a change or revision to existing policies and practices.

Consultation

Members in Ward 14 and 15 have discussed these applications in depth (circulated to Members) with colleagues from Police Scotland and have expressed a desire to purchase these rapidly deployable cameras.

1.0 Background

- 1.1 The *Domehawk* cameras which were purchased over a decade ago in the Glenrothes area have become obsolete. Police Scotland provide regular input and reports at Ward meetings. Anti-social behaviour remains a real issue affecting many people and impacts on quality of life.
- 1.2 Modern high-tech cameras are more effective, providing clearer, sharper images, and are easier to move and deploy. Cameras have been purchased by Ward 13 and Ward 15 and have made an impact on reducing crime figures.

2.0 Issues

- 2.1 There was a question relating to revenue costs, and this has been overcome. Elected Members in Ward 15 have been impressed by the difference made by deploying these cameras and have expressed a desire to purchase two more which will help tackle anti-social behaviour, fly-tipping and vandalism around their Ward area.
- 2.2 Ward 14 Members have agreed that rapidly deployable and mobile CCTV Cameras will help tackle anti-social behaviour and reduce incidences in their Ward area.
- 2.3 The total cost for the cameras will be split between the Local Community Planning budgets of Wards 14 and 15. The cost for installation and commissioning of Eclipse Rapid deployment cameras with built in Wi-Fi, recording and 4G capability is £31,631 (£15,81.50 per ward £7,907.75 per camera package). The cameras will be deployed across the Wards with discussion and agreement between Elected Members and Police Scotland.

3.0 Conclusions

- 3.1 The new CCTV cameras which have been requested, produce high quality images and can be rapidly deployed to various hot spots across Ward 14 and Ward 15 areas. Police Scotland will liaise closely with Local Councillors about positioning of cameras, targeting certain areas and will provide updates on their effectiveness.
- 3.2 Elected Members are asked to approve the purchase of the CCTV cameras for both wards. The cameras will be deployed to tackle all forms of anti-social behaviour, vandalism and fly-tipping.
