factsheet 1 February 2010 Assessing publicly usable greenspace in Fife's towns and villages

The purpose of this factsheet is to briefly explain the process used to assess greenspace.

Why assess?

For centuries there has been a realisation of the need of publicly usable greenspace in towns and villages.

In Ceres, games have been played annually since 1314 on the Bow Butts a greenspace in the centre of the villages. Provosts in Cupar bequeathed land to the people in 1870 for a park. Up till now we have known the need but haven't known if each town or village has enough greenspace for the population, the quality or if it is in walkable distance.

For the first time Fife Council have carried out a Greenspace Audit and show the state of greenspace across the area.

What to assess?

From the air Fife is a green space and most of this land is agricultural fields. The audit assesses the land which the public can freely use and access in and around the towns and villages. Agricultural Land has not been included.

Other land which could be publicly usable but has restricted access or use has been recorded but not assessed has been classed as functional.

in Fife was 6 hectares per 1,000 of the population. The quantity of 6 hectares per 1,000 of the population was used to assess each settlement. Settlements below the average may need enhanced protection, and more greenspace may be needed.

Publicly Usable Greenspace

includes

parks, amenity residential greenspace, play areas, sports areas, natural greenspace (such as woods, beaches) and allotments.

These are the types of greenspaces audited

Functional Greenspace which is public building grounds, amenity transport & business greenspace, open water, golf courses and burial grounds.

How to assess?

Assessment of greenspace has 4 audits. These are :

- 1 The amount of land quantity
- 2 The quality of land
- 3 Access to the land
- 4 how the public view greenspace

The amount of land – quantity

To be able to assess the amount of publicly usable greenspace, all greenspace was mapped digitally, using GIS (Geographic Information System) software. The area in hectares of all land with in defined settlement boundary was added up. The total amount of publicly usable greenspace was also added. The average amount

4 – how the public view greenspace

The People's Panel were used to ask questions on what the public think and use greenspace. Some 800 people across a range of ages, gender and settlements took part in this particular panel. Questions included were how

The quality of land

For the audit quality was defined as how multifunctional a space is. Five multifunctional criteria were assess.

- 1. Accessible, and connected greenspaces:
- 2. Attractive and appealing places:
- 3. Biodiverse supporting ecological networks:
- 4. Greenspace should promote activity, health and well being
- 5. Greenspace should have community benefits:

460 acre sized sites were assessed. The average score was 60%. Sites that were below the 60% score were rated poor, which means that they need improved.

3 - Access to the land

This assessment audited the walking distance from houses to a greenspace. A distance of 250 metres was set and the size of greenspace was ½ an acre (0.2 hectares). The distance of 250m was used, as research has shown that this is a reasonable distance for an 8 year old children to walk to a greenspace.

Computer mapping and software were used to assess access.

62% of the settlement population living in domestic properties are with in 250m walking distance of a 0.2 hectare publicly usable greenspace. 60% was used the rate settlements. Settlements with below 60% figures were seen as needing to improve access.

people use and rate five different types of greenspace, namely parks, open spaces, play areas, woodlands and beaches/coast.

The results showed that the main reason to visit a greenspace is to go for a walk. 46% visited on foot and 49% visited by car. 28% visit a greenspace once a week and 42% visit once a month. Participants were most satisfied with the appearance and maintenance of parks and least satisfied with play areas.

Assessing the state of greenspace in a settlement

The results from the quantity, quality and access audits were used to assess a settlement. Using all three indicators is useful. For example Lochgelly has average amounts of greenspace and average access and below average quality of spaces.

Cupar has below average quantity and access but above average quality sites.

Dunfermline could be said to have a reasonable greenspace network. Quantity and quality meet but access is below average. Access in parts of the settlement may need to be further investigated. Dunfermline has a concentration of high quality spaces in the town centre.

Actions to improve access to quality greenspace

- Access could be improved in parts of the town
- 22 sites which are below average could be improved.
- Duloch Park is of low quality, this is a park which has the potential to be a town park. This should be a priority greenspace to improve.

In terms of Kirkcaldy because of the quality of the town parks, areas of low neighbourhood access may be mitigated with access to quality town park. Linktown is a good example of this.

- Path network may need to be improved to increase access in Kinghorn.
- Increase the amount of greenspace in Auchtertool.
- Investigate countryside access around Auchtertool.

Kirkcaldy was above the average (65%) this may be due to parts of the town such as Sinclairtown, Gallatown, Hayfield and Linktown having areas of no neighbourhood access. The North West part including Dunnikier, Templehall and Strathallan have high access. The audit has only assessed the neighbourhood level. In terms of Kirkcaldy because of the quality of the town parks, areas of poor neighbourhood access may be mitigated with access to quality town park. Linktown is a good example of this.

Assessment of Greenspace Network

The town of Kirkcaldy has a good greenspace network. There is a high amount of greenspace within the settlement and access meets the average. Due to the amount of sites assessed for quality, the score is above average. There are concentrations of poor quality greenspace in Templehall. The greenspace network varies in the town with Gallatown and Sinclairtown having low access to quality greenspace.

Beveridge Park is the highest rated space in Fife. The community rating of the beach was low and although the esplanade was not quality rated, this is of low quality.

Actions to improve access to quality greenspace

- The beach and esplanade could be Kirkcaldy's greatest greenspace asset and should be a priority for the strategy. These sites should be important and strategic spaces for Kirkcaldy and Fife.
- Gallatown and Sinclairtown may have low quantity, quality and access issues which sould be investigated and improved
- The quality of greenspaces in Templehall should be improved.
- 29 sites which are below average could be improved.
- Gourlay Street Greenspace, Kirkcaldy has been rated very low and should be a priority to be improved.

- When the audit was carried out the Kirkton Burn greenspace was fenced off with temporary chespale. This fencing should be removed.
- Burntisland Links as the Town Park should continue to have improvements made.

- Wilderness Plantation has a very low quality path network and needs to be improved.
- Orchardhead wood should also be a priority, due to low access to the site.
- Heath Road greenspace has been rated a high priority due to anti-social behaviour. The school playing field fence has created access problems.
