Cupar Ward with Monimail Community Council Local Place Plan: Accompanying Statement


Dear Fife Council Planning Department,

The boundary of the Cupar Ward with Monimail Community Council Local Place Plan is shown in red on the map below.



Cupar Development Trust have prepared this Local Place Plan as a Community Controlled Body as set out in the Community Empowerment (Scotland) Act 2015. A statement from Fife Council confirming that we meet the qualifying criteria for a Community Controlled Body is included in the plan.

The Cupar Ward with Monimail Community Council Local Place Plan contains a list of 49 key policy proposals. In addition we have included a separate section of 14 general suggestions from the public regarding the proposed Cupar North development.

When preparing this Local Place Plan, we have carefully considered all relevant National and Fife Council documents: in particular the National Planning Framework (NPF 4) for Scotland 2045; the FIFEplan Local Development Plan 2017; Plan4Fife and the Plan4Fife - North East Fife Local Community Plan 2023-26. These documents are fully referenced and summaries of each document, as relevant to this plan, are given in sections 13 and 14 of this LPP. All individual proposals contained within this LPP are in agreement with the priorities and guidelines laid out within these (many are referenced in individual proposals). The only exception to this rule is where an individual proposal is not in alignment with the current Local Development Plan, this is listed on the individual proposal and a full justification for the suggested change is given.

Where we have requested an amendment to the Local Development Plan (Fifeplan 2017), this is based on achieving the vision and core values expressed during the extensive public consultation process.

Our vision is that Cupar should be vibrant, thriving, friendly and well connected. Our communities will be sustainable in response to the changing climate. People of all ages and backgrounds will be involved in making this a place where people want to live, work, and visit. **The Core Values** for delivering our vision and proposed projects, agreed at our four themed Local Place Plan public consultation meetings, are: Circular Economy, Community Control, Sustainability, Diversity and Inclusion, Health and Wellbeing, Feeling Safe, Ageing Well, Lifelong Learning, Productive Working (with a particular emphasis on retaining young people/school leavers in our community).

Many of the proposals were suggested during our recent Cupar and Country Community Action Plan 2003, which identified several priority areas where change is urgently needed to support our local community.

We received no suggested alterations or objections from our Statutory Consultation consultees, so no changes have been made to the consultation copy. This is reflected in section 12 of this Local Place Plan document. The Statutory Consultation copy of this Local Place Plan is available to download on the same webpage listed above.
