Review of Scheme for the Establishment of Community Councils

Report by: Head of Legal and Democratic Services

Wards Affected: All Wards

Purpose

The purpose of the report is to seek approval to undertake a review of the Scheme for Establishment of Community Councils in accordance with the statutory framework.

Recommendation(s)

It is recommended that the council agrees to: -

- (1) note that a review of the Scheme for Establishment of Community Councils for Fife will be undertaken in accordance with section 53 of the Local Government (Scotland) Act 1973;
- (2) note that the proposed Scheme of Establishment is based on the Improvement Service's Model Scheme for the Establishment of Community Councils, as appropriately tailored for Fife's requirements; and
- (3) proceed with the consultation process set out with indicative timeline at Appendix 1, delegating to the Head of Legal and Democratic Services to make any necessary minor amendments.

Resource Implications

The review will be carried out within existing resources.

Legal & Risk Implications

The review requires to be carried out in terms of the Local Government (Scotland) Act 1973. There is a reputational risk to the Council if sufficient consultation does not form part of the process, which the proposed process addresses.

Impact Assessment

There are no known environmental or privacy impacts. The report does not propose a change to the Council's existing policies and practices and regard shall be had to equalities issues as part of the consultative process. A full impact assessment will be carried out on the proposed new Scheme when it is submitted for approval. The consultation process will take into account accessibility requirements.

Consultation

The Head of Legal and Democratic Services has been consulted on the preparation of this report.

1.0 Background

- 1.1 Community councils were established in Scotland following the Local Government (Scotland) Act 1973. They bridge the gap between local authorities and communities and help make public bodies aware of the opinions and needs of the communities they represent.
- 1.2 Local authorities have statutory oversight of community councils and are required by law to consult community councils relating to planning applications and licencing matters. In conducting their activities, community councils must always adhere to the law, the terms of the Scheme and the Community Councillors Code of Conduct.
- 1.3 Community councils are governed by the Fife Council Scheme for the Establishment of Community Councils in Fife and its boundaries, which was last reviewed on 11 March 2021 (para 220 of 2021.FC.259 refers).
- 1.4 In October 2023, the Improvement Service, published a new suite of Scotland-wide model documents for community councils, including a Model Scheme for the Establishment of Community Councils and Good Practice Guidance. The Improvement Service collaborated with local authority community council liaison officers, community councils, Scottish Government, COSLA and the Scottish Community Development Centre as part of the review to update the Model Scheme and all associated documents. These were subsequently endorsed by the Scottish Government. Local authorities have been asked to adopt the suite of model documents in part or in full as dictated by local requirements. 2.0 Conclusions

- 2.1 As set out in Section 53 of the Local Government (Scotland) Act 1973, the council having regard to changing circumstances shall from time-to-time review schemes approved under Section 52 of the Act. They shall give public notice of their proposals inviting any community council concerned and the public to make representations in regard of the proposals.
- 2.2 Following the introduction of a new Model Scheme and documents by the Improvement Service, endorsed by the Scottish Government, it is considered

- appropriate to undertake a review of the current Scheme and associated documents, before the next round of community council elections in 2027.
- 2.3 The proposed timetable for the review and public consultation is contained in Appendix 1.
