


# RECREATIONAL FACILITIES BEVERIDGE PARK, KIRKCALDY

# **Description and Use**

The subjects comprise the trading locations shown on the location plan above

Boating pier coloured cyan,

Putting green/crazy golf coloured green,

Bouncy castle coloured red, and an

Additional expansion area — coloured magenta.

The successful applicant will be responsible for the removal of litter from within 20 metres of the sites that is attributable to their operations.

#### **Operating hours**

Trade is restricted to between 7 am and 8 pm seven days per week subject to a minimum of trading on each day of clement weather during Fife Council's summer school holidays.

# **Services/installations**

Mains electricity is available at the bouncy castle site at the licensee's cost.

#### **Equipment**

Fife Council will provide the following:

Two wooden sheds
One metal shed
One small skiff boat
Eight rowing boats and 20 oars
Five 4-Seater swan pedalos
Three 2-Seater swan pedalos
Two sets of 18 Golf pins
56xputters
18 crazy golf obstacles
Two bogey hole cutters

The licensee will be responsible for supplying a bouncy castle and other inflatables at their discretion. Annual PIPA Test certificate required for each inflatable.

# <u>Licence fee</u>

The licence fee will be payable monthly in advance by direct debit in three equal instalments for the period 1st June to 31st August each year. The concession may be operated year round with no charge for the period from 1st September to 31st May each year.



#### Rateable value

Not currently entered in the Valuation Roll.

# **VAT**

The licence fee is exempt from VAT.

# **Statutory consents**

The licensee is responsible for obtaining any statutory consents which may be required, including planning permission in connection with the intended use of the Subjects.

#### **Term**

A five year licence with an option for either party to terminate at any time on three months' prior notice.
